### **MOBILE HOME AND RV PARK REQUIREMENTS**

#### Where are RV Parks and Mobile Home Parks allowed?

- New RV parks and additions to existing RV Parks only allowed in Rural District with a conditional use permit
- Additional RV spots for existing mobile home parks that also allow RVs only allowed in Rural District with a conditional use permit
- New Mobile Home Parks (No RVs) and additions to existing mobile home parks (No RVs) allowed in Rural, R4, and MHP Districts with a conditional use permit

## What is required for each permit type?

#### **NEW**

#### New RV Parks and new Mobile Home Parks that allow RVs

- A plot plan showing the layout of the park, including roads, RV/mobile home spots/sites, and service building
- A complete set of plans for the service building
- An electrical plan for the entire park
- A plumbing plan for the entire park
- Fees: \$0.50 per square foot for the service building (minimum \$500) plus 1 electrical and 1 plumbing trade permit for each spot (\$125 each)

## New mobile home parks that do NOT allow RVs -

- A plot plan showing the layout of the park, including roads and mobile home spots/sites
- An electrical plan for the entire park
- A plumbing plan for the entire park.
- Fees: 1 electrical and 1 plumbing trade permit for each spot (\$125 each)

## **ADDITIONS**

# Additions to existing RV parks and additions to existing mobile home parks <u>that allow</u> RVs (When there <u>IS an existing service building on site)</u>

- A plot plan showing the layout of the park, including roads, existing and proposed RV/mobile home spots/sites, and the existing service building
- A layout of the existing service building (should include floor plan showing existing number and type of fixtures)
- An electrical plan for the addition to the park, including where it is tying into the existing
- A plumbing plan for the addition to the park, including where it is tying into the existing
- Fees: 1 electrical and 1 plumbing trade permit for each spot (\$125 each)

# Additions to existing RV parks and additions to existing mobile home parks that allow RVs (When there is NO existing service building on site)

- A plot plan showing the layout of the park, including roads, existing and proposed RV/mobile home spots/sites, and service building
- A complete set of plans for the service building
- An electrical plan for the addition to the park, including where it is tying into the existing
- A plumbing plan for the addition to the park, including where it is tying into the existing
- Fees: \$0.50 per square foot for the service building (minimum \$500) plus 1 electrical and 1 plumbing trade permit for each spot (\$125 each)

## Additions to existing mobile home parks that do NOT allow RVs

- A plot plan showing the layout of the park including roads and existing & proposed mobile home spots/sites
- An electrical plan for the addition to the park, including where it is tying into the existing
- A plumbing plan for the addition to the park, including where it is tying into the existing
- Fees: 1 electrical and 1 plumbing trade permit for each spot (\$125 each)
