Where provisions of the following supplementary data differ from those of the original Contract Documents, this Addendum shall govern and take precedence.

Acknowledge receipt of the addendum by inserting its number on the Quote Sheet of the Bid Documents. Failure to do so will cause the bid response to be rejected.

Quoters are hereby notified that they shall make any necessary adjustments in their estimates on account of this Addendum. It will be construed that each Quote Sheet's proposal is submitted with full knowledge of all modifications and supplemental data specified herein.

- AD2.1 There was a Non-Mandatory Pre-Quote Conference held at 10:00 A.M. on February 18, 2025. Attached are the Conference Notes and Sign-In Sheet numbered AD2-3 through AD2-4.
- AD2.2 Contractor Questions & Answers:
  - Q: I saw in the drawings that the project calls out GEOFLO DRAINAGE & SHOCK ATTENUATION BLANKET but in the specifications, it does not state anything about a shock/drainage pad. I am wondering if there will be an addendum to clarify.

- A: The concrete infill with geoflo blanket or a standard stone base, with strip drains as included in the current specs is allowed. See Attached Detail No. 4 numbered AD2-5.
- Q: The specifications indicate the new field is to be built with a traditional base including 4" of base stone and 2" of finish stone, but the drawings indicate the base to be concrete with a geogrid. Can we get some clarification as to how this will be built?
- A: The concrete infill with geoflo blanket or a standard stone base, with strip drains as included in the current specs is allowed. See Attached Detail Nos. 4 numbered AD2-5.
- Q: It was mentioned at the prebid that another contractor that is doing the parking lot would spread existing dirt over the new flag football field. Please confirm that this contract will only require the contractor to grade the dirt on the new flag football field and not have to move it from an existing pile on site.
- A: Paving contractor to spread excavated material over proposed field. Turf contractor will be required to grade and compact subbase material. If additional excavation is required, Owner to provide location on site to store excess material.
- Q: Is Owner's Protective Liability Insurance required?
- A: Yes. Follow insurance requirements as detailed in the specifications.
- Q: Can the owner provide a budget for the project?
- A: \$250,000


